Abyrx will use Kairuku to seamlessly integrate SurgiCor's representatives and their affiliate partners into Abyrx's existing distribution network, which currently comprises several hundred cardiac, craniomaxillofacial, and spine representatives. Abyrx will maintain responsibility for its own product training and payment of compensation owed to SurgiCor and its partners.
